Report of Career guidance & Placement Cell 2021-22

Career guidance & Placement Cell is providing opportunities for students to get employment prior to completion of their degree courses. In Pandemic period and after pandemic, Career Guidance & Placement Cell conducted various offline/online training program for students which not only benefitted students to improve their skills but these training provided jobs to students.

The cell has approached various organizations and Multinational Companies to conduct the online as well as offline campus Recruitment programme in our college campus. In academic year Placement cell not only conducted online training but also offline training after September 2021. Training programs includes interview skills, business etiquettes, work readiness, Resume building, Communication Skills etc. This is the process by which many students have really benefitted in the past.

We motivated students for different competitive exams like Banking exam, Staff Selection Commission, Railway recruitment exam, police Recruitment exam etc. Time to time updates of job recruitment in Government and Private Sector is given by cell.

Following Placement trainings were conducted in Year 2021-22 (offline/Online mode).

1. **Techno serve Job Readiness Programme** - Career Guidance & Placement Cell conducted 2 batches of Techno serve training for TYBCOM students in this academic year. 1st batch in June 2021 & 2nd batch in August 2021. For August 2021 batch orientation were conducted on 18th Aug.2021. Training includes “**Techno serve Job Readiness Programme**” which includes ‘**Communication Readiness**’, ‘**Career Readiness**’, and ‘**Work Readiness**’. 35 Students from final year were enrolled for batch & 03 students got placement through this program.
2. **5 days course on IT & Technologies with Jetking-** Placement Cell conducted 5 days free of cost training from 3rd Aug. 2021 to 7th Aug. 2021.on IT & Technologies. Training covers topics related with IT & Technologies, Personality Development, communication skills etc. 45 students attended the course.
3. **Barclays -GTT certificate course on life skills** - Career Guidance & Placement Cell with GTT conducted certificate course on Life skills & Aptitude from 6th September

to 18th September 2021. Course covered Interview skills, connect with work, self-awareness, grooming, body language, confidence, Resume, Rejections, Corporate readiness, values, ownership, respect, team workshop Analysis, mock interviews & group discussion as well as training on questions related with the Aptitude test. 57 students registered for the course.

4. **American India Foundation with Citi Bank Certificate Course**-Placement Cell with AIF -Citi bank run Employability and Skill Development program for college students. Under this training Courses like Retail Sales Associate, Retail sales Associate Cashier, Business Correspondence and Business Facilitator, Account Executive are covered in online mode, training also cover topic like Soft skill and Life Skills to students during course time. From FYBCOM to TYBCom total 40 students done registration for different courses run by AIF. 32 students have successfully completed the training.

5. **American India Foundation with IBM**- The IBM Skills Build Platform a skilling delivery platform but a whole ecosystem that enables skill development, access to jobs globally, access to live sessions from global skill experts, one to one discussion among a large student community. The objective was to onboard students and provide them with training sessions and help them generate certificates. 351 Students Received Learning from IBM Skills Build Platform and got Certificates.

6. **Barclays-GTT Certificate course on Communication skills (30Hrs.Certificate course)** - Placement Cell with Communication department conducted value added course on Communication Skills with GTT under Barclays project from 20th Jan.2022 to 4th Feb. 2022. 55 students completed 30 hrs. Barclays skill program.

7. **GTT-RBL BFSI course**- 10 days Course started from 24th Feb.2022 to 11th March 2022, in college premises in offline mode. Total 112 students done registration for the programme. Students have completed 120-hour program including Domain training in BFSI Personal effectiveness, Communication Readiness, Career Readiness and Work Readiness. Training was delivered through Offline class. The students have also undergone individual counselling during the program, post training,

pre-placement and also post placements. 20 students got placement in HDB Financial Services and 16 students got placement in Eminent Research. Remaining students are continuing to receive updates about vacancies undergoing interview and placement processes.

8. **Barclays-GTT course on Interview skills**-From 21st March to 26th March 2022, Placement cell conducted 1-week Interview skills & Personality Development course for students which covers job interview skills, Interview tips & group discussion tips for Interviewer.

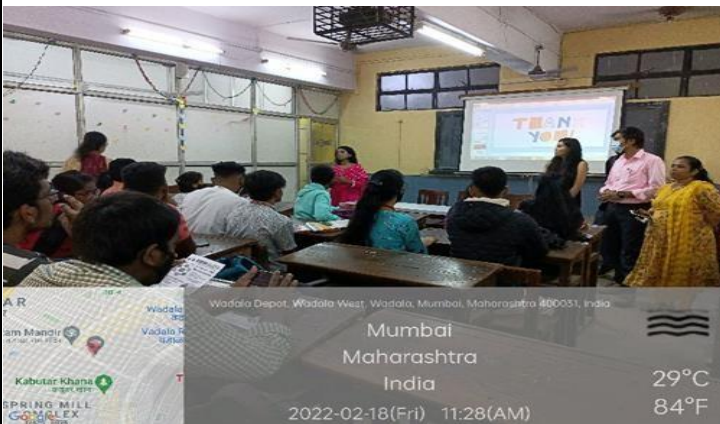

Following introductory speech, Mr. Amogh Darekar gave a speech on Nutrition. As the name suggests, 'nutrition' includes in itself 'nutrients' which can be broadly classified as carbohydrates, proteins, fats, vitamins, minerals, roughage, and water. A balanced amount of these nutrients in the right proportions constitute a healthy diet.

The words 'balanced' and 'right proportions' mentioned previously are key to life when it comes to consuming nutrients. 'Optimum Nutrition' is defined as eating the right amount of nutrients in a proper schedule to achieve the best performance and longest possible life time in good health. The importance of nutrition can be visibly highlighted by the increasing number of nutrient deficiency diseases such as night blindness, scurvy, cretinism, anemia, and nutrient excess health-threatening conditions like obesity, metabolic syndrome, and other cardiovascular anomalies.

Undernutrition in underdeveloped and developing countries has been marked by malnutrition due to lack of even the basic staple nutrients causing diseases like marasmus and kwashiorkor. Animal nutrition on the molecular level comes from nitrogen, carbon, and hydrogen compounds. Nutrients are the building blocks of the food chain, which interlink to form food webs and influence world food production via biodiversity.

Similarly, plant nutrition is referred to as the chemicals that are necessary for plant growth and other physiological processes in plants like metabolism, transport, photosynthesis, etc. Nutrients essential for plants are obtained from the soil, air, sunlight, and as a whole from the earth; thus, the nutrients can be recycled and renewed, making it easily available for sustenance of life.
