1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Dr. Ambedkar College of Commerce and Economics, established in 1972, is a renowned institution in Mumbai, India. Founded by Bharat-Ratna Dr. B. R. Ambedkar, it is conveniently located in the heart of the city, offering easy commute for staff and students. The college aims to provide education to all, offering admission to all aspiring young students with a fee structure in line with Mumbai University norms.

The college, affiliated to Mumbai University, aims to provide higher education to underprivileged communities, particularly SC, ST, and backward communities. It offers various courses, including HSC in Commerce, MCVC Vocational courses, B.Com Degree Courses, self-finance courses, post-graduate courses, and Ph.D. programs. With 6000 students, the college adheres to university norms and offers various courses, including B.Com., M.Com., and Ph.D. programs. The college has introduced job-oriented Engineering Diploma and Certificate skill development courses for degree college students in the academic year 2022-23. Delegates from Khadigram, Mumbai conducted a seminar on and gave knowledge on hobby courses like embroidery, Cake making etc to promote entrepreneurship and to equip them in self employment. We admit students with two attempts also hence we promote job oriented skill development courses that would promote career development. The college was following Credit Based semester and grading system (CBSGS) till and from the year the college follows Based Credit System (CBCS) as revised by the University of Mumbai. The college was accredited by NAAC in the first cycle that was conducted in 2004 with grade 'C++', in the second cycle of NAAC which had been conducted in 2011 was reaccredited with Grade 'B' and in the third cycle of NAAC conducted in 2017, the college was reaccredited with B+.

The college has spacious library and a vast playground encouraging students to take part in in sports activities. The college duly promotes extra-Curricular activities like NSS, NCC, Students' Council and Cultural Association by forming committees. The college fervently strives to impart quality education and skill development to the students and to fulfill the requirements of NAAC. We are submitting the self study report for the 4th cycle of reaccreditation of NAAC.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

Institutional Strengths:

- 1. The college provides admission to all aspiring students.
- 2. The college gives admission to the economically backward students by accepting half fees and gives three month time to pay the remaining amount.
- 3. The college has Gymkhana and vast playground.
- 4. Spacious and well stocked library and partially digitalized with soul. 0.03 software.
- 5. Free Remedial coaching for XII Std. and for Third year B.Com students.
- 6. Add on courses are conducted in GST and Taxation
- 7. Active placement cell and free training is conducted by various companies under CSR every academic year.
- 8. Junior College and Senior College credit societies provide deposit schemes and loan facilities to the teaching and non-teaching staff.
- 9. The college has submitted a proposal of approximately Rs.14 crores, for the building repairs to the Social Welfare department, Government of Maharashtra. Waiting for the sanction of the same.

Institutional Weakness

Weakness:

- 1. Limited financial resources as the college does not take any donations and depends only on the fee collection from the students.
- 2. The number of teaching and non-teaching staff had been reduced drastically as NOC was not granted by the Mumbai University for Fresh Appointments.
- 3. More focus on Research activities of the faculty members is necessary.
- 4. As we accept students with minimum passing percentage in 12th standard, the faculty members has to pay extra attention in teaching.
- 5. The college offers only Commerce related courses.
- 6. The college needs to develop infrastructure to introduce diversified courses.

Institutional Opportunity

Opportunities

1. Active Placement Cell with reputed companies which facilitate job opportunities to the deserving students on completion of the training programs conducted by the respective companies.

- 2. The college gymkhana and sports Association motivate the students to take part in various activities conducted by the University of Mumbai.
- 3. Free course on English Language and Communication is conducted every academic year.
- 4. Digital English Lab has been installed.
- 5. Skill development department of the college, follows the guide lines of the National Skill Development Course, Delhi, is well equipped for the electrical and automobile courses. The exposure to the skill development courses opens up avenues for skill oriented job opportunities to the students.
- 6. The Equal Opportunity Cell and Women Development Cell of the college conducts job oriented training programs.

Institutional Challenge

Challenges

- 1. Students with minimum passing marks and with two attempts are also admitted and improving the results is challenging but before every semester Guidance Lectures and Revision Lectures are conducted.
- 2. During Covid 19 the college conducted online lectures through Google Meet and the students who do not have smart phones and laptops found it difficult to attend the lectures.
- 3. The college functions smoothly by forming various committees. But after the retirement of the senior staff over the period, the vacancies have not been filled. Hence with limited staff the college has to carry on with all the necessary work.
- 4. Propelling alumni to take active part in the development of the college.
- 5. Students prefer self financing courses like Bachelor of Management Studies (BMS), Bachelor of Accounting and Finance (BAF) and hence students' strength in regular B.Com course has reduced.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The college follows the curriculum prescribed by the University of Mumbai. The college strives for effective curricular planning. Academic calendar and master time table are prepared and displayed at college website. Class wise and individual teacher's time table is prepared. Departments prepare subject wise teaching plan. Apart from traditional lecture method, guest lecture, field visit, workshop, seminar and quiz competition are also organised for better understanding of the learners. Examination is conducted at the end of the semester. B.com. program has foundation course and computer subject with 25 marks allocated for internal assessment. B.com. (Banking & Insurance) program has 75:25 pattern providing 25 marks for internal assessment in all courses. Post graduate M.com has 60:40 pattern wherein 40 marks are assigned for internal assessment. College has conducted Add on courses on GST- a Practical Approach, Service Marketing, English Speaking Course and Bridge course on Basic Mathematics & Statistics. Women Development Cell, National Service Scheme conducts activities like seminar, street play, awareness rally, guest lecture, beach cleaning, yoga, peace rally which helps in integrating cross cutting issues with the curriculum. Learners also engage in project work and internship. Feedback is collected and analysed, it is displayed on college website and shared with respective departments for their improvement and development.

Teaching-learning and Evaluation

The main objective and goal of the college is to provide quality education through holistic education. Equal opportunities have been given to all the students irrespective of caste and background. Students with lowest percentage are also given admission so that they are not deprived of education. The admission process of the college is managed by the admission committee. Internal Assignment is compulsory for subjects like Foundation course, computers in B.com course and also for the subjects in unaided course. adheres to the guidelines prescribed by the University of Mumbai from time to time. Unfair means Committee takes strict action against the students who are caught so that the students are discouraged to do such action in future. Remedial coaching is provided for the students for those who economically weak, but are good in academics. Besides this regular mentor- mentee interaction takes place. Bridge courses are designed to help students to overcome barriers in learning. Students are encouraged to participate in various inter-college competitions. They are also encouraged to appear for competitive exams. Well stocked libraries are provided with advance reference books. Special lectures being arranged, eminent speakers from industry are being invited. Job fairs, Seminars and Workshops have been organized. Toppers have been facilitated with certificates. Most of our students get placed in good companies with the help of our college placement cell. Along with conventional lecture method, ICT methods has also been used. Both faculty and students have access to use modern teaching aids. Teachers used latest tools to make teaching effective. college with the help of senior faculty members monitors all the curricular, co-curricular activities in the college and ensures to provide all the necessary support to teachers and students for better and learning process.

Research, Innovations and Extension

The college has a Ph.D research centre affiliated to Mumbai University in Commerce that specializes in Trade, Transport, and Industry. The Ph.D research centre of our college was started in the year 2010-2011. The research guides of our college Research Centre are Dr. Raj Shoste & Dr. Reshma More who give intellectual guidance to the researcher scholars. During the academic year 2018-19 to 2022-23 two of our research scholars have been awarded Ph.D degrees by the Mumbai University. Faculty members are encouraged to present and publish papers at seminars and conferences by our Research and Development Cell. Aspiring research scholars are provided with budgetary support by the college management to publish their research. For Under graduate (B.Com) and Post Graduate students (.M.Com). Google Class Meet online link was prepared for online lectures during the Covid-19 pandemic. In order to develop social skills, students are given plenty of opportunities. Health and HIV/AIDS awareness programmes, tree plantation, road safety campaigns, voter registration drives, and Covid-19 Vaccination Drives have been organized by NSS volunteers. Rural camps have been conducted by the NSS unit at Tribal Residential School in Raigad District to make them aware of the problems faced by tribal students. During the blood donation camp, NSS volunteers tested blood groups and collected blood donations. Two workshops were conducted by the college, one on Intellectual Property Rights (IPR), and another on "Tips to Academic Writing" and one national seminar on "Gender Sensitisation & Women's Rights"and the proceedings of the same were also published in Aarhat Publication and Aarahat Journals. As part of the gymkhana department's activities during 2018-19, we organized the West Zone Inter University Kho-Kho (Men) Tournament, the All India Inter University Kho-Kho (Men) Tournament, and the 22nd Inter University State Sport Festival Kho-Kho (Boys & Girls) Tournament. Inter-college tournaments were organized by the department in 2022-23.

Infrastructure and Learning Resources

The People's Education Society constructed a ground plus two storey building in 1970 to accommodate various requirements for the staff and the students for three year B.Com degree Course. The college offers self- finance degree course in Banking and Insurance and a Post Graduate course in M.Com. at flexible timing to make the best use of the college's infrastructure. While allocating class rooms for different courses, the timetable committee strictly adopts university norms. Different-abled students have access to ramps at the entrance, ground floor washrooms and a railing on the stairway. The college has a Language Lab, a Computer Lab, and 8 class rooms equipped with ICT. Everyday requirements and cleanliness are supervised by the vice-principal and registrar. The college has specially appointed four members from House -keeping service in addition to regular cleaning staff of the college to maintain cleanliness in the college campus. In addition to computers, air conditioners, Xerox machines, water purifiers, and other equipment, the college has AMC for maintenance for the same. As per the Mumbai University guidelines the college regularly pay group Insurance for the students. The library is situated on the first floor that is duly furnished with text books, reference books, newspapers and journals. The library is spacious with separate sections for boys and girls. Library is open from 8 a.m. to 5 p.m.

Student Support and Progression

The criteria V comprises of the information pertaining to student support and the consequent development of the institution. The college provides a platform to the students for developing academic, personal, and administrative skills. The college forms various committees every that motivate the students to participate in various academic and non-academic events and activities. As part of capability enhancement programs, the institute offers programs for the development of personality, ICT skills, and life skills. Students at the college come from a variety of backgrounds, including SC, ST, OBC, NT, SBC, and minorities. SC/ST/OBC and other reserved category students receive scholarships and free ships on time. Institutions provide concessions on fees and instalment plans to economically disadvantaged students to take Admission. The remedial coaching and guidance lectures accentuate to impart knowledge on the curriculum and take relentless efforts to fetch good results.. Various competitive examinations, including IBPS, Railway examinations, UPSC, SSC, MPSC, are offered free training and coaching under the UGC Merged Scheme. There are special guest lectures organized for students to help them prepare for CET, NET, SET, MBA exams, etc. Our college offers an add-on Special English course for the students every year. Additional courses are offered as add-ons and enrichment to improve students' skills. Further, the institution has NSS, NCC, Sports, and Cultural Committee. The performance of our students in sports is at its peak due to a higher participation rate at the national, state, and university levels. A well-equipped sports room and open space are available for practicing indoor and outdoor games at the college. The institution hosts sports inter-collegiate events in cricket, football, volleyball, table tennis, kabaddi, and kho-kho. The Grievance Redressal Cells, the Anti-Sexual Harassment Cells, the Anti-Ragging Cells, the Women Development Cells, and the Career Guidance Cells play an important role in understanding the problems of students and counselling them accordingly.

Governance, Leadership and Management

To achieve the vision and mission of our Founder Chairman, the great son of India Bharat Ratna Dr Babasaheb Ambedkar. The College takes stringent measures adhering to the tenets of Dr. Ambedkar. The College functions under Peoples' Education Society. The college has formed College Development Committee for better

governance. As per university rules, the College Development Committee is a statutory body that comprises of external representatives from industry, law, and internal members of teaching and non-teaching staff of the college. An institution's principal is its leader. Under her guidance and leadership, academic and administrative work is carried out. In order to improve quality, the principal ensures that all measures are implemented at the ground level. The college uses CIMS software for administration. Admissions have been conducted in accordance with the University of Mumbai's admissions circular. There is an aided Commerce section and unaided courses like BBI, B.Sc. IT and M.Com. The college collects feedback from the students, parents, and which is duly analysed and shared with the teachers to evaluate teaching performance. and the remedial measures are taken accordingly. The IQAC committee collects API from the teaching faculty to assess the academic performance. Both curricular and extracurricular academic activities are conducted by the respective committees of the college. Implementing the academic calendar, teaching plans, and peer team recommendations of NAAC is the role of IQAC.In order to achieve academic excellence, the college encourages its faculty to participate in faculty development programmes, training programmes organized by universities, seminars, workshops, and conferences. IQAC plays a key role in taking developmental decisions of the college, including infrastructure and academic development. IQAC is supervised by the principal, and the committee sets up schedule of meetings with different departments to assess the progress and performance.

Institutional Values and Best Practices

Institutional values have intrinsic worth. The purpose of our institution is supported by best practices that add value to human life. The development of an institution is aided by it, which is a source/means of performing social responsibility. Adapting to the emerging challenges the college focuses on gender equality, environmental consciousness, and sustainability, inclusiveness and professional ethics issues on a regular basis. The Foundation course included syllabus for first- and second-year students that aims to increase awareness among the students. Various social activities are arranged by the Women Development Cell of the college.

Alternative energy sources such as use of LED bulbs and power efficient equipment are available at the institution and energy conservation measures such as degradable and non-degradable waste management, green campus initiatives and barrier free environment have been provided by the College. Environmental and energy quality audits are conducted regularly by the Institution. The college organized various activities to increase the awareness of Constitutional obligations among the students and the employees. Various organizations and multinational companies have approached the Career Guidance & Placement cell to run an online and offline campus recruitment program on our college campus. Our college gymkhana motivates students to participate in a variety of sporting events for which the college provides special training. The college also focuses on the overall development of the students and promotes joint curriculum activities through NCC, NSS, Student Council, Cultural Association and Gymkhana. The college has been providing remedial coaching to students from socially and economically backward classes. Certificate Value-added courses have been introduced to the students. The college is running several programs that focus on Skill Development, Job Skills, and Personality Development in collaboration with various NGO organizations to improve the students' skills. After successful completion of these programs, deserving students get immediate placement. College puts in all efforts to educate and make them financially independent, enabling them to become a part of the main stream of the nation. College has job oriented skill based certificate courses on Automotive sector, power sector and tourism sector.

The college organized various online skill development and enhancement activities to provide holistic development to the learners

Students were encouraged to use mobile based application software for their practical exam.

Teachers use ICT

Faculties were trained to use ICT enabled tools effectively and efficiently. The institution acquired licensed LMS software Microsoft Teams for delivering lectures. The faculty is provided with the requisite facilities for preparation of computer aided teaching learning materials.

The online teaching learning facility was provided by the college during Covid -19 pandemic period. The Google meet platform was used by college during this period. The Google meet platform has been put to extensive use during the pandemic times, when distance teaching became the only option of communication between teachers and students. Regular classes are taken through this online platform according to a fixed routine set by the institution. Study materials were uploaded by the teachers in the college website. A well –equipped open-access computerized library with internet facilities is available for faculty. E-resources are available through national networks-(ShodhSindhu)

Both faculty and students have access to modern teaching aids. Teachers adopted various tools and utilities such as power point presentation, audio-video aid, etc. for making the teaching more effective.

ICT tools enabled the students to have better learning experience and hence the entire process of teachinglearning worked towards efficient use of technology and provided enriched learning to learners. The most challenging job of teaching in online method was effectively handled by all the teachers. The responses of the students were gathered during the lectures through the dialogues and the hand raising options so as to ensure that all the learners get the concepts fully clarified.

The college follows the guidelines given by the University of Mumbai. The examination rules, regulations, evaluation procedures, exam time tables and notices are communicated to the students and their parents through prospectus. The examination time table are displayed on the College website. Rules / process regarding internal exam / evaluation as well external exam were informed to the students in the beginning of the academic year. The students were explained about the marking scheme of different courses in the class by the teachers. Internal assessment is conducted fairly and the students are permitted to check their marks sheet if they have any doubt. Internal Assignment is compulsory for Foundation Course for F.Y.B.Com., S.Y.B.Com and T.Y.B.Com students. Only for those T.Y.B.Com students who have opted for Computers. M.COM & BBI, BSc.IT courses have a compulsory internals assessment process. FYBCOM & SYBCOM students have submitted internal assignment for 25 marks for the Foundation course subject through online mode by email; some students have submitted assignments through offline mode. M.COM, BBI, BSC.IT students submitted internal project assessment as per the submission schedule given by the particular department. Attendance records and marking schemes are maintained by the departments and the consolidated mark sheets are submitted to the examination committee. The assessment mechanism and the declaration of results for internal and semester-end

examination was done as per the norms given by the University, for the respective programmes. Records of all students appearing for Regular exams, ATKT exams, additional exams, and all other exams are maintained. The Examination Committee informs the faculties to set Multiple Sets of Question Papers. Question papers are set at the University level. Exams have been conducted systematically, where a centralized seating arrangement is followed. Distinct question papers were generated from the common set of questions set by teachers. The results of internal-external examinations, assignments, as well as overall development activities, are utilized to determine knowledge and abilities.

The college principal conducts regular meetings with the Vice-Principal and Head/Incharge of the departments for the implementation and attainment of program outcome, course outcome and Program specific outcome. Every department Head/ In charge conducts meetings at the beginning of the academic year for each semester with the faculty members, discussing the teaching plan as well as CO, PO, PSO. Apart from the regular lectures every faculty member shares relevant points and notes with the students through WhatsApp group, website & email. After completion of the syllabus, departmental Head/Incharge hold meetings with the faculty members about syllabus completion and ensure about the attainment of course outcome as well as give instructions to the faculty members to conduct additional revision lectures before semester exam. Question papers are set as per the guidelines of the University of

Mumbai.

The college evaluates attainment of the programme Outcomes and Course Outcomes by analyzing the results achieved by the students. The performance of the learners in their examination determines the achievement of the course outcome. This course outcome is then matched with the programme outcome and cumulative result is analyzed to evaluate the achievement of POs through the COs.

Every teacher has to maintain a diary wherein all the lecture details taken on a particular day have been mentioned. For low performing students especially those who are coming from weak financial background, remedial measures are taken for the benefit of the students.

The performance of the students is discussed in the departmental meetings chaired by the Principal and efforts are directed to improve the future results.

6.3 Faculty Empowerment Strategies

6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

College has separate feedback committee which collects feedback from the student which is analyzed and shared with the teachers to evaluate teaching performance of the faculties. The principal personally talks to the teacher in case the feedback of student is not satisfactory and gives suitable advice for

improvement of performance. The IQAC of the college obtains API forms as per the norms laid down under the performance based appraisal system applicable to the teachers. It is a comprehensive document covering the information about teaching & learning, evaluation, research & publication and extension activities etc. The head of the departments submit their report annually which list out all the activities conducted by the department.

The college has taken effective measures for teaching and non teaching staff as:

For Teaching Staff:

- a) College gives the Advance payment against the salary to the teachers. b) Teachers can take the loan from the Credit Society established by the colleges of the PE Society.
- c) Reverse Osmosis that is RO water facility is available for the teachers in the college.
- d) College has provided separate Kitchen facility to the teaching staff.

For Non-Teaching Staff:

- a) College gives the festival advance to the non-teaching staff.
- b) Non-teaching staff can get advance payment against the salary from the college.
- c) Nonteaching staff can also take the loan from the credit society of the college.

The Foundation course is a course designed for first- and second-year students that focuses on raising awareness about gender equity among students. Online and offline activities were arranged by the Women Development Cell, NSS, and Cultural Association. An online one-month certificate course on 'Self Defence for Women's' (30 hours) was organized by the Women's Development Cell from December 3rd to December 17th, 2021. A rally on women's empowerment and safety awareness was organized by NSS. A lecture titled 'Opportunities for Employment for Women' was organized by NSS. NSS conducted a project with Akshara NGO on gender equity and organized a poster making competition on the theme of 'Save Girl Child'. In association with RAK police station under the guidance of ACP Kadam madam, students of cultural unit performed street plays on women's safety named 'TU AAHES NA' at various places of Wadala., Mr. Hritvik Lingayant, wrote the script of the street play in which students got appreciation .

Special facilities for women are available at the college, such as:

- Safety and Security guards: security guards including women security guards are stationed at the main gate. CCTVs are installed at all places in the college premises and connected to the principal's office, and the head security guard conducts regular rounds in the premises.
- Compulsion of Identity Card/ Entry in Visitors book: Students' entry in the college premises is permitted only with a valid Identity Card.
- Orientation of First Year Students: First year students are oriented at the beginning of the year with functioning of important committees like Discipline, Anti-ragging, Internal Complaint Committee, and Students Grievance Redressal Committee.
- Vigilance of Discipline committee: Discipline committee members maintain required law and order in college premises.
- Medical and Hygiene facilities: First aid facilities are kept at student centric locations.
- Common Rooms: Separate common room facility is available for girls to rest. A lady attendant is deputed for the girls' common room. There is a vending machine for sanitary napkins in the girls' common room.

- 2. Objectives of the Practice (100 words)
- 1. To develop job skills in the students.
- 2. To give maximum job opportunities to the students.
 - 1. The Context (150 words)-
 - 2. The Career Guidance & Placement cell has approached various organizations and multinational companies to conduct an online and offline campus recruitment program on our college campus. In academic year placement cell not only conducted online training but also offline training after September 2021. Training programs included interview skills, business etiquettes, work readiness, Resume building, Communication Skills etc. This is the process by which many students have really benefitted in the past., During the pandemic and after, many people lost their jobs due to lockdown. Various online skill development programs and job opportunities for students have been organized by the Career Guidance and Placement Cell of Dr. Ambedkar College during the lockdown period.
 - 3. The Practice (400 words)

The Career Guidance and Placement Cell provides opportunities for the students to get employment prior to the completion of their degree courses. In the pandemic period and after the pandemic, the Career Guidance and Placement Cell conducted various online and offline training programmes for students, which not only helped students to improve their skills but also provided job opportunities.

Following Placement trainings were conducted in Year 2021-22 (offline/Online mode)

- 1. Techno serve Job Readiness Programme Career Guidance & Placement Cell conducted 2 batches of Techno serve training for TYBCOM students in this academic year. 1st batch in June 2021 & 2nd batch in August 2021. For August 2021 batch orientation were conducted on 18th August, 2021, Training includes "Techno serve Job Readiness Programme" which includes Communication Readiness, Career Readiness, and Work Readiness. 35 students from final year were enrolled for batch & 03 students got placement through this program.
- 2. 5 days course on IT & Technologies with Jetking- Placement Cell conducted 5 days free of cost training from 3rd August, 2021 to 7th August, 2021 on IT & Technologies. Training covers topics related with IT & Technologies, Personality Development, communication skills etc. 45 students attended the course.
- 3. Barclays -GTT certificate course on life skills Career Guidance & Placement Cell with GTT

conducted certificate course on Life skills & Aptitude from 6th September to 18th September 2021 .Course covered Interview skills, connect with work, self-awareness, grooming, body language, confidence, Resume, Rejections, Corporate readiness, values, ownership, respect, team workshop Analysis, mock interviews & group discussion as well as training on questions related with the Aptitude test. 57 students registered for the course.

- 4. American India Foundation with Citi Bank Certificate Course-Placement Cell with AIF -Citi bank run Employability and Skill Development program for college students. Under these training Courses like Retail Sales Associate, Retail sales Associate Cashier, Business Correspondence and Business Facilitator, Account Executive are covered in online mode, training also cover topic like Soft skill and Life Skills to students during course time. From FYBCOM to TYBCom total40 students done registration for different courses run by AIF. 32 students have successfully completed the training.
- 5. Barclays-GTT Certificate course on Communication skills (30Hrs.Certificate course) Placement Cell with Communication department conducted value added course on Communication Skills with GTT under Barclays project from 20tr' Jan.2022to 4thFeb.2022" 55 students completed 30 hrs. Barclays skill program
- 6. GTT-RBL BFSI course- 10 days Course started from 24th February, 2022 to 11th March 2022 in college premises in offline mode. Total 112 students did registration for the programme. Students completed 120-hour program including Domain training in BFSI personal effectiveness, Communication Readiness, Career Readiness and Work Readiness. Training was delivered through Offline class. The students had also undergone individual counselling during the program, post training, pre-placement and also post placements.20 students got placement in HDB Financial Services and 16 students got placement in Eminent Research. Remaining students are continuing to receive updates about vacancies undergoing interview and placement processes.
- 7. Barclays-GTT course on Interview skills-From 21st March to 26th March 2022, Placement cell conducted l-week Interview skills & Personality Development course for students which covers job interview skills, Interview tips & group discussion tips for Interviewer.
- 8. Antrang Foundation's Career Ready Employability Skills Training Placement Cell conducted 3 batches for 'Antarang -Career Ready Program' for degree college students in offline mode and 3 online batches for Junior College students. College received certificate of appreciation from Antarang foundation as well as received Certificate of Achievement for ensuring maximum number of students to complete the Career Ready Employability Skills Training in 2021 -22.
 - 1. Problems encountered and resources required (150 words) –

The college provided an online lecture platform in which Google Meet was used for placement training. In the initial phase of the pandemic, students were not familiar with online lectures, but over time they became familiar with the online portal. Students who went to other states and villages in Maharashtra were unable to attend the training due to poor network issues. After the pandemic, we started all training in offline mode as per the guidelines of Mumbai University. While shifting to offline mode, initially, students were reluctant to go for offline mode, but teachers and trainers explained the importance of face-to-face training and how it is more effective compared to online mode.

7.3 Institutional Distinctiveness

7.3.1

Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Our college offers admission to economically backward students. During the pandemic, the college permitted students to pay fees in two instalments, as many students' parents lost their jobs during the lockdown period. The college conducted admissions, an orientation programme, regular lectures, guest lectures, and exams in online mode. The college created an official Google Meet account for all classes. For online admission, used CIMS software. An orientation programme was conducted online for the newly admitted students. Teachers informed students about the syllabus, exam pattern, course outcomes, various curricular and extracurricular activities, placement opportunities for the students from college, and administrative procedures (i.e. railway concession, scholarship, fee payment procedure, etc.). After October 2021, regular offline lectures were started as per the guidelines of the University of Mumbai.

Our college provides remedial coaching for the TYBCOM students, where students get extra coaching after their regular lectures. Our students are getting an 'O' grade by attending remedial coaching classes.

The online exams for Semester I, III, V and semester IV and VI were conducted as per the guidelines issued by the University of Mumbai, using ETS 360 software. For semester II, offline exams were conducted. Every year college provides remedial coaching to TYBCOM students . Remedial class students show improvement in their results after attending these classes. The college arranges revision lectures after every semester for the student's progress. The placement cell conducted placement related trainings throughout the year, which provided job opportunities to the deserving students.

The college has Commerce, self-financing Banking Insurance course, BSc IT course MCom courses. Certificate Value-added courses have been started for students. Certificate curse in English Tally is run by college this year. Several programs on Skill Development, Job Skills, and Personality Development in collaboration with various NGO run by college for enhancing students' skill. Students are getting immediate placement after successful completion of such programs. Earn while learn program with Kotak education foundation run for FY SY students in academic year 2019-20. Techno serve C2C as well as Disha program by NSDC-Citi bank run for last year students, students got job after completion of training. The College is run by Peoples Education Society, Mumbai, which has been established by the Symbol of Knowledge, Architect of Indian Constitution, Bharat Ratna Dr. B. R. Ambedkar. It was his cherished dream to provide Education to All especially to the depressed and oppressed section of the society. The college has rich student diversity comprising of boys and girls from SC, ST, OBC, NT, SBC category. Many of these students are from poor families without any educational background and many

of them are the first learners in their family. College takes all the efforts to educate and make them financially independent enabling them to be a part of main stream of the nation. The college has been imparting remedial coaching to the students from socially and economically backward class. The Business Communication department conducted a course on English speaking. The placement cell conducted various placement-related programs during the pandemic period, and students were able to obtain job opportunities. Placement Cell conducted NSDC Citi bank, CSR training for TYBCOM students on 'Business Correspondent Business Facilitator (BFSI)', conducted Techno serve training for TYBCOM students from 20th July 2020 to 3rd September 2020. Training includes 'Techno serve Job Readiness Programme' which includes 'Communication Readiness', 'Career Readiness', and 'Work Readiness'. Conducted RBL-GTT batch -1 training conducted from 17th August 2020 to 18 September 2020 on 'Soft skills & Financial Markets 'by Natarajan Education Society under CSR project of RBL. Barclays-GTT training on 'Corporate Readiness'-01week program for FYBCOM,SYBCOM & TYBCOM students conducted from 14th Jan.2020 to 20th Jan.2020. Program includes 10 modules which covers Interview skills, Confidence building, Resume making, Corporate Readiness, Time Management, SWOT Analysis, Mock Interview & Group Discussion. 23 Students successfully completed this training.
